- 4. Discussion on Shared Understanding of SSF Guidelines and Principles
  - *Chair Johnathan Li* proposed for consideration adding two principles to the SSFAC List of General Principles that will serve as a guideline for SSF Review and Future Budget Considerations. The two principles are as follows:
    - "SSFAC will continue to use the *Guidelines for Implementing the Student Services Fee Portion of The University of California Student Fee Policy* as strict guidelines until a new guideline us drafted and agreed upon by SSFAC and campus leadership.
    - Any programs and services supported by tuition specifically listed in *Regents Policy 3101: The University of California Student Tuition and Fee Policy* will not be funded by SSF: "In addition to funding programs and services supported by Tuition (such as student financial aid and related programs, admissions, registration, administration, libraries, and operation and maintenance of plant) ..."
  - After the committee as a whole reviewed and discussed the implementation of the principles, *Chair Johnathan Li* asked for a motion to adopt the two principles.
  - Motion to Adopt the General Principles by Derreck Carter-House, Seconded by Jose Cortez-Hernandez.
    - General Principles Approved Without Objections
  - The Committee reviewed the programs and services of the Academic Resource Center, Career Center, and International Affairs and discussed future budget considerations for the departments with reference to the List of General Principles.
