- 4. Vice-Chair Nominations and Interview Questions

      - 7. How do you plan to disseminate the information and efforts of SSFAC across campus?
      - 8. How do you plan to support the Chair in your vice chair role overall?

- 6. SSFAC 2018 2019 Priority and Allocation Summary
  - The committee reviewed The Final Recommendations for the Chancellor's Designee Approval for the Fiscal Year of 2019 2020.
  - *Lenin Kuri* indicated that the final benefits allocation amounts were reduced from 1.8% to 0.9% due to a decrease in the composite benefits rate for Fiscal Year 2019 2020.
  - *John Haberstroh inquired* if the amount reduced from the benefit rate was distributed to any departments and *Militza Seehaver* clarified that it was moved to Central Campus Reserve for potential re-allocation for the 2019 2020 Fiscal Year.
  - *Glenn Stanley* inquired how the Committee's Preliminary Recommendations reflect the finalized allocations by the Chancellor's Designee: Vice Chancellor of Student Affairs.
  - *Militza Seehaver* indicated that the Recommendations presented by the 2018 2019 SSFAC were approved as presented by VCSA.
