a) STIP - Starting July 1, 2023, the Provost will retain STIP earnings. This campus decision was twofold: (1) Aligns with the Budget Model refinement providing resources centrally since all other resources flow out to campus units; and (2) Impact23 project principle was to use out of the box functionality and limit customizations, and thus, the STIP distribution to campus units was a customization in Peoplesoft in where Oracle can't replicate out of the box.

1) FY23's projected revenue reported last year was overstated by \$8,495,149. The overstatement was due to adding the 2022-23 Cohort HC, and not decreasing the HC from the cohort from the AY2022/Earlier cohort base. UCR SSF report link found here: <https://ssf.ucr.edu/annual-reports>

1. Describe how 2022-23 Student Services Fee (SSF) revenue was used on the campus. To what extent did SSF revenue uses diverge from original plans in the wake of the COVID-19 pandemic? If SSF revenue diverged from original plans, please explain.

The SSF revenue use did not change from its original plan. We have moved to a post-pandemic approach with operations continuing as planned. All student service operations and programming moved back to in-person in '22-23.

All funded departments submitted requests to the committee for review and consideration as per normal processes. All funded departments moved back programming to in-person with a few virtual options based on needs. The committee acknowledged and approved submitted requests as all programming were deemed appropriate in a "normal" programming environment.

This year, we continued the normal process for proposal calls which was prepared at the end of fall quarter and requests were vetted via the committee during the winter/spring quarters. Departments were invited to present proposals to the full SSFA committee. In addition, sub-committees were formed and assigned to functional areas/departments and conducted in-depth reviews and scrutiny of each department's proposals. The committee conducted voting to support budget augmentations within the available funding for this particular year and per Regents Policy 3101.

After thorough evaluations, the committee submitted its recommendations to the VCSA for final approval. Departments are notified of the approved budget augmentations and/or denials per the committee's recommendations once reviewed and approved by the VCSA. For archiving purposes, final approved allocations are provided to the Chancellor's Office.

2. Describe the consultation process of your campus with your local Student Fee Advisory Committee. Did your campus consultation process change in Spring 2023? If yes, to what extent?

The consultative process did not change. VCSA leadership and committee involvement remained the same.

The Student Services Fee Advisory Committee is under the purview of the Vice Chancellor of Student Affairs (VCSA). As such, the Vice Chancellor oversees and engages with this student led committee in strategizing, prioritizing, and vetting requests for funding each fiscal year per Regents Policy 3101. This included requests from departments approved to request new funding. Additionally, UCR's Central Budget Office staff attended at least one meeting to present a campus-wide financial report and enrollment data and projections for the committee's understanding of UCR's financial standing for planning purposes.

The committee is comprised of 13 voting members which include undergraduate and graduate students, faculty, and staff. There are also two staff members assigned to support the committee and serve as liaisons to the Vice Chancellor of Student Affairs attending all Student Services Fees meetings except for the sub-committee meetings.
