- The totality of all subcommittee recommendations is around \$400,000 over budget. The Committee discussed reducing subcommittee recommendations

- for department programs to 50%, except for student salaries and benefits. The Committee discussed keeping the subcommittee recommendations for graduation ceremonies the same amount for now.
- The Committee discussed block-funding for tech-related needs and potentially tasking departments to allocate block-funding amongst their own needs, followed by a report back to the Committee.
- The Committee is still \$270,000 over the target total after cutting all programs to 50%. Committee Members noted that for events, there are other funding sources on campus, and deliberated cutting funds for professional development under Ethnic and Gender in hopes of preserving staff rather than prioritizing travel. Committee Members also stated that within their subcommittee discussions, their subcommittees recommended cutting professional development for students to allocate funding for Veterans Resource Center. The Committee agreed to cut all professional development and conference travel needs but raised the question of the applicability for either professional staff or student conferences.
- The Committee recommended cutting 25% of student employment salaries across the departments.
- The Committee further discussed cutting all programs to 40% of the requested amount.
- Sarah Dillon asked if campus departments are notified how much funding is available across the board. Alice Alcantara explained that campus departments are only notified of the amount that they were recommended and allocated.
- The Committee deliberated on cutting all graduation ceremonies to 75%.

3. Chair and Vice Chair Election Discussion

- Alice Alcantara announced that nominations are officially open for the positions of Chair and Vice Chair and invited interested Committee members to submit their nominations via email. Committee members can self-nominate or nominate others as well.
- Chair Funanya Ikechukwu stated that nominees for Chair will be asked questions, and presented to the Committee the Chair election questions from last year.
- *Sarah Dillon* suggested rephrasing the last question to "How do you see this role working in conjunction with the Vice Chair?"

4. Open Comments

• Sarah Dillon stated an intention to not participate in SSFAC next year.

5. Chair Comments

- Chair Funanya Ikechukwu thanked the Committee for their efforts to deliberate and propose budget recommendations thus far and announced that the Committee will finalize bylaw updates in the next meeting.
- Chair Funanya Ikechukwu announced that the Vice Chair elections did not have to be held in Week 5, but it was agreed upon by the Committee in Winter

- quarter to streamline the Vice Chair election process along that of the Chair. Elections for the position of Chair will take place in Week 5.
- Chair Funanya Ikechukwu announced that graduating student members will be contacted regarding an SSFAC graduation sash.
