Call to Order: 1:12 PM

- 1. Approve the Agenda
 - Motion to Approve the Agenda by Camerom Springer, Seconded by Grace Su.
 - Agenda Approved Without Objections
- 2. Approve Meeting Minutes May 8th, 2024
 - Motion to Approve the Meeting Minutes of May 8th, 2024, by Funanya Ikechukwu, Seconded by Ruhi Barman.
 - Payton DePalma noted a typo under Subcommittee's
 Recommendation for Undocumented Student Programs that read
 "Priority 1: Butterfly Project Partial Funding of \$15,000." The typo was corrected by Angela Chien to reflect the amount of \$150,000.
 - Meeting Minutes of May 8th, 2024
- 3. Finalize Bylaw Discussion and Vote
 - Chair Jose Alvarez drew attention to Article IV Sec. A and proposed the addition of a subclause under Sec. A Clause 4 "Duties." Chair Jose Alvarez stated that the proposal is to ensure a transition procedure between the outgoing Chair and Chair-elect to aid in leadership. The letters shall outline continuity between leadership and be well-documented within the Committee for review by any committee member and future Chair.
 - The new clause will read "n. Meet at least once to review the SSFAC Bylaws with the Chair-elect and will write a letter detailing the initiatives and challenges during their past tenure, along with future work left unresolved."
 - Chair Jose Alvarez drew attention to Article IV Sec. B and proposed the addition of a subclause under Sec. B "Duties" to clarify the vagueness of Vice Chair responsibilities." Chair Jose Alvarez explained that the proposal shall clarify the responsibilities of the Vice Chair and provide guidance in the Vice Chair's role in the Committee. Vice Chair Funanya Ikechukwu asked if committee members are still able to contribute to the design and development of social media posts. Chair Jose Alvarez affirmed and clarified that the Vice Chair would be responsible for posting and social media page logistics.
 - The new clause will read "e. Responsible for managing the SSFAC social media page, which involves consistent posting, answering students' questions, and moderation as deemed necessary by the Chair and the Committee"
 - Before voting on the Bylaw Amendments, the Committee reviewed and discussed the new proposed language in the Bylaw Amendments document provided by *Chair Jose Alvarez*.
 - Bylaw Amendments for Fiscal Year 2024-2025:
 - Article I-III: No Changes
 - Bylaw Item #1 Article IV, Section A, Clause #4
 - Adding Clause #4.n as a new subclause: "n. Meet at least once to review the SSFAC Bylaws with the Chair-elect and will

write a letter detailing the initiatives and challenges during their past tenure, along with future work left unresolved."

 - Add Clause #4.e as a new subclause "e. Responsible for managing the SSFAC social media page, which involves consistent posting, answering students' questions, and moderation as deemed necessary by the Chair and the Committee."

4. Year End Report

- Chair Jose Alvarez gave an overview of the Year End Report thus far. It will be sent to the Vice Chancellor of Student Affairs once it has been completed. Chair Jose Alvarez noted that the Bylaw and Student Survey sections are still a work in progress. Chair Jose Alvarez shared the recommendations noted thus far in the Year End Report, including efforts to increase accountability, on recruitment to ensure quorum, and defining attendance measurements. Chair Jose Alvarez stated that the Year End Report will be shared with the Committee for feedback and inquired if the Committee have any recommendations to include in the report.
- Vice Chair Funanya Ikechuwku recommended to include limits of how much work a Committee member can do to make up for their absences. *Chair Jose Alvarez* affirmed and stated that it is unfair for Committee members who attend meetings weekly. *Vice Chair Funanya Ikechukwu* further proposed tabling to promote the SSFAC, emphasizing that one-on-one conversations are more effective recruitment strategies.
- *Grace Su* recommended introducing student committee members to the RSVP feature on the calendar invitations to further account for quorum.

Phoebe Lee affirmed that tabling is a good idea, but students are more enticed
when there is swag at tabling. Alice Chavez noted that swag is a feasible idea,
as Student Affairs had requested additional funding for expenses in such
instances.

5. Chair Elections

- Chair Jose Alvarez explained that logistics of the Chair election, and votes will be submitted to Angela Chien via secret ballot. As a nominee for Chair of SSFAC for the 2023-2024 academic year, Funanya Ikechukwu was interviewed by the Committee with a set of questions used in the prior year. The committee members took turns to read the questions as follow:
 - What prior experience with managing budgets, student outreach, or otherwise do you have to bring to this role?
 - Do you see a need for a potential improvement in the organization and communication within SSFAC? If so, what would these improvements entail?
 - What are your strategic goals for SSFAC this year and how do you plan to represent UC Riverside at CSF meetings and with external partners such as UCOP, etc.?
 - What are some critical challenges you think SSFAC is currently facing? What suggestions or solutions do you have to address the challenges?
 - How would you deal with internal conflicts within the Committee?
 Provide a past example of a workplace or team conflict you've managed.
 - What challenges do you think undergraduate and graduate students are currently facing that relate to the Student Services Fee?
 - How do you plan to advertise and recruit committee members for the following year?
 - What kind of relationship would you like to have with ASUCR and GSA or other committees on campus?
 - What are your thoughts on SSFAC's involvement with the referendum?
 - What sort of relationship and responsibilities do you see yourself having with the Vice Chair?
- The Committee evaluated the responses of *Vice Chair Funanya Ikechukwu* and collectively agreed to elect *Vice Chair Funanya Ikechukwu* as the Chair of SSFAC for the 2024-2025 academic year.

- 6. Review Submitted Applications
 - *Chair Jose Alvarez* noted that the applications were reviewed with the GSA ans ASUCR president. *Chair Jose Alvarez* outlined that applications were

assessed based on the student applicant's diverse perspective, the quality of the student applicants' answers, and the student applicant's activity in the student community. *Chair Jose Alvarez* noted that some student applications were not presented to the Committee due to suspicions that it has been altered by AI.

- 7. Vote For New Committee Members
 - In preparation for the 2024 2025 Academic School Year, SSFAC is in need of one new Undergraduate Members and three new Graduate Members to replace the 2023-2024 Committee Members who will not be returning. After careful consideration and evaluation of the applicants, the Committee has selected a total of one Undergraduate Members and two Graduate Members to appoint. The Committee will resume voting on new Committee Member in the upcoming school year.
